

DIRECTIONS TO OUR NEW OFFICE:

FROM THE NORTH/SOUTH Garden State Parkway to Exit 138 – Kenilworth. At the end of the ramp, turn left onto the Kenilworth Boulevard. Go (1.7 miles) through the center of Kenilworth and continue on the Boulevard through Nomahegan Park. At the light where the Boulevard intersects with Springfield Avenue (on the left side) – continue straight through the light. The Boulevard now becomes Springfield Avenue. Continue for 1.1 mile to our office on right. You will pass through the light at the intersection of Broad Street. Wind down through the curves and pass by Echo Lake Country Club on the left, William’s Nursery on the Right. Come to a light at the intersection of Echo Lake Park – Mountainside Crossing on the left – Westfield veterinarian’s office on right and funeral parlor on the right. After the next light (Cardinal Drive)Our office is the next lot on the right side – If you passed the Christadelphian’s Church or Rt 22, you have gone too far.

Take Route 22 West to the Westfield exit – just after you pass Bennigan’s and Bob’s Stores and under the over-pass. This jug-handle will put you right onto Springfield Avenue – going over the top of Route 22. – at the first light you come to On the left is Park Place Legal Center and Condos. Continue through this light but stay to the left. As the road bends to the left, the office is right after the stone church (Christadelphian) on the left. It is easy to get to the office this way, however, some people prefer not to travel on Route 22 so I have written two ways to do this.

FROM THE WEST:

From Route 22 East: Pass the SONY Theatres in Mountainside. Just past the CompUSA on the right side take the exit to the Westfield – Cranfordjust before the overpass. At the end of the ramp, you make a quick left and then right turn onto Springfield Avenue at the light. Stay to the left after the light. You will immediately see the stone church (Christadelphian) on the left side – our building is next to it.

From Interstate 78 East: You can either “drop-down” from I-78 to Route 22 in Scotch Plains (ie. Bonnie Burn Road) or go through the Watchung Reservation and come down New Providence Road – and follow the above directions. You can also travel through on I-78 to the Millburn –Union Exit. At this exit take the ramp onto Meissel Avenue and it will come to two traffic lights (the first one going toward Millburn, the second one being Morris Avenue – Route 124). Go straight through both lights and stay on Meissel Avenue in Springfield – all the way through Springfield until it comes to the overpass for Route 22 (at this point, Meissel Avenue *becomes* South Springfield Avenue. Just after passing over Route 22 you will see Park Place Legal Center and Condos on the left – go through the light and stay in the left lane. Springfield Avenue begins to curve to the left.

Just as you pass the stone church (Christadelphian) on your left – our building is the next building.

FROM THE SOUTH:

Take the Garden State Parkway North to exit 138 (this is the exit after our present exit for Cranford). Make a left turn onto the Kenilworth Boulevard. Go through the center of Kenilworth and continue on the Boulevard through Nomahegan Park. At the light where the Boulevard intersects with Springfield Avenue (on the left side – coming from Cranford) – continue straight through the light. The Boulevard now becomes Springfield Avenue. Continue for a short time through Cranford and, shortly thereafter, it becomes Westfield. Pass through the light at the intersection of Broad Street. Wind down through the curves and pass by Echo Lake Country Club on the left, William’s Nursery on the Right. Come to a light at the intersection of Echo Lake Park – Mountainside Crossing on the left – B.J. Fields Restaurant on the right, veterinarian’s office on right and funeral parlor on the right. Our office is the next lot on the right side – just before the Christadelphian’s Church.

FROM MORRIS COUNTY, SUSSEX COUNTY:

Take Route 24 South from Morristown area to the Union-Millburn Exit (after 24 and I-78 merge). At this exit take the ramp onto Meissel Avenue and it will come to two traffic lights (the first one going toward Millburn, the second one being Morris Avenue – Route 124). Go straight through both lights and stay on Meissel Avenue in Springfield – all the way through Springfield until it comes to the overpass for Route 22 (at this point, Meissel Avenue *becomes* South Springfield Avenue. Just after passing over Route 22 you will see Park Place Legal Center and Condos on the left – go through the light and stay in the left lane. Springfield Avenue begins to curve to the left. Just as you pass the stone church (Christadelphian) on your left – our building is the next building.

FROM STATEN ISLAND, RAHWAY, LINDEN, ELIZABETH AND POINTS EAST:

In most cases, it is simply best to go to our old office (Cranford) and, instead of turning onto North Union Avenue off Springfield Avenue – continue on Springfield Avenue past Union County College till Springfield Avenue comes to a T-intersection at a light. Make a left at the light – it is still called Springfield Avenue. It will wind into Westfield – pass the light at Broad Street. You will pass Echo Lake Country Club on the left and William’s Nursery on the right. Then you will come to a light (Mountainside Crossing and the entrance to Echo Lake Park on the left) – go straight through and pass B.J. Fields Restaurant, veterinarian’s office on the right and funeral parlor on the right. Our office is the next right turn – just before the stone church and the light.
